GENERAL
REQUIREMENTS

article 1

In this Regional Regulation, the following terms are defined:

1. The area is Surakarta City.
2. Regional Government is the administration of regional affairs
governance by the Regional Government and Council
Regional People's Representatives according to the principle
of autonomy and
assistance tasks with the principle of broad autonomy
breadth in the system and principles of the Unitary State
Republic of Indonesia as referred to in
Constitution of the Republic of Indonesia Year
1945.
3. The Regional Government is the Mayor as an element
organizer of Surakarta City Regional Government
who leads the implementation of government affairs
become the authority of autonomous regions.
4. The Mayor is the Mayor of Surakarta.
5. Regional Revenue and Expenditure Budget which
hereinafter abbreviated as APBD is a financial plan
annual Regional Government discussed and
jointly approved by the Regional Government and the
Council
Regional People's Representatives, and determined by
Local regulation.
6. Regional Government Capital Participation is a form of
Regional Government Investment in Business Entities with
get ownership rights.

7. Surakarta City Regional Drinking Water Public Company is a regionally owned business entity where all the capital is owned by the Region in the form of regional wealth which is separated and not divided into shares.

CHAPT
ER II
QUANTITY AND
SOURCES

Article 2

- (1) Capital Contribution of Surakarta City Government in Surakarta City Regional Public Drinking Water Company set at Rp. 2,500,000,000.00 (two billion five hundred million rupiah).
- (2) Amount of Surakarta City Government Capital Contribution At the Regional Public Company for Drinking Water in the City Surakarta up to this Regional Regulation set at Rp. 126,798,617,064.00 (one hundred twenty six billion seven hundred and ninety eight million six hundred and seventeen thousand sixty four rupiah).

Article 3

Capital Contribution of Surakarta City Government in Surakarta City Regional Public Drinking Water Company as referred to in Article 2 paragraph (1) is given in Fiscal Year 2021.

Article 4

Regional Government Capital Participation comes from the Regional Budget.

Article 5

Regional Government Capital Participation Budgeting as referred to in Article 2 are grouped into in the Regional Financing Expenditure Budget type Regional Government Capital Participation.

CHAPTE
R IV
FORM OF CAPITAL
PARTICIPATION

Article 6

- (1) Form of Regional Government Capital Participation to Surakarta City Regional Public Drinking Water Company is in the form of money.
- (2) Regional Government Capital Participation as referred to in referred to in paragraph (1) the management is carried out in accordance with with the provisions of laws and regulations.

R V
USE, ADMINISTRATION AND
ACCOUNTABILITY

Article 7

Capital Contribution of Surakarta City Government in Surakarta City Regional Public Drinking Water Company used for the development of bottled drinking water.

Article 8

Administration And accountability management Regional Government Capital Inclusion is implemented accordingly with Government Accounting Standards.

Article 9

Surakarta City Regional Public Drinking Water Company every year must submit accountability report in the form of a summary of Performance Realization and Financial Reports Company to the Mayor through the Supervisory Board.

CLOSING

Article 10

This Regional Regulation shall come into force on the date enacted.
