BY THE GRACE OF GOD ALMIGHTY

MAYOR OF SURAKARTA,

Considering: a. that the Capital Participation of the Surakarta City Government in the Surakarta City Regional Drinking Water Company in the Framework of Developing Wastewater Program Services is intended to realize community welfare through services provided by the Regional Drinking Water Company;

b. that the Capital Participation of the Surakarta City Government in the Surakarta City Regional Drinking Water Company in the Framework of Developing Wastewater Program Services is very necessary for the development of wastewater programs in meeting the needs of the community in creating a clean and healthy environment while increasing the potential for regional original income based on the Investment Feasibility Analysis Report Number 017/AUP/M NK.05/XI/2020, dated November 9, 2020;

c. that the Surakarta City Government's Capital Participation in the Surakarta City Regional Drinking Water Company in the Framework of Developing Wastewater Program Services needs to be stipulated

by Regional Regulation in accordance with the provisions of Article 78 paragraph (2) of the Regulation.

Government Regulation Number 12 of 2019 concerning Regional Financial Management;

d. that based on consideration as referred to in letter a, letter b and letter c, it is necessary to stipulate a Regional Regulation concerning Capital Participation of the Surakarta City Government in the Surakarta City Regional Drinking Water Public Company in the Framework of Developing Wastewater Program Services;

DECIDE:

To stipulate: REGIONAL REGULATION CONCERNING CAPITAL PARTICIPATION OF THE SURAKARTA CITY GOVERNMENT IN THE REGIONAL PUBLIC DRINKING WATER COMPANY OF SURAKARTA CITY IN THE FRAMEWORK OF DEVELOPING WATER PROGRAM SERVICES.

GENERAL REQUIREMENTS

article 1

In this Regional Regulation, the following terms are defined:

1. The area is Surakarta City.
2. Regional Government is the implementation of government affairs by the Regional Government and the Regional People's Representative Council according to the principles of autonomy and assistance tasks with the principle of the broadest possible autonomy in the system and principles of the Unitary State of the Republic of Indonesia as referred to in the 1945 Constitution of the Republic of Indonesia .
3. The Regional Government is the Mayor as an element of the Regional Government administration that leads the implementation of government affairs that are the authority of the autonomous region.
4. The Regional People's Representative Council, hereinafter abbreviated as DPRD, is a regional people's representative institution that functions as an element of the Regional Government administration.

5. The Mayor is the Mayor of Surakarta.

6. Budget Income and Regional Expenditure, hereinafter abbreviated as APBD, is the annual financial plan of the Regional Government which is discussed and jointly approved by the Regional Government and the DPRD, and stipulated by Regional Regulation.

7. Regional Government Capital Participation is a form of Regional Government Investment in a Business Entity by obtaining ownership rights.

8. The Surakarta City Regional Drinking Water Public Company is a regionally owned business entity where all of its capital is owned by the Region in the form of regional assets that are separated and not divided into shares.

CHAPTERII
QUANTITY AND SOURCES

Part One

Amount

Article 2

The Regional Government's Capital Participation in the Surakarta City Regional Drinking Water Company in the context of developing wastewater program services is set at IDR 9,000,000,000.00 (nine billion rupiah).

Article 3

The amount of Regional Government Capital Participation in the Surakarta City Regional Drinking Water Public Company up to the time this Regional Regulation is stipulated is Rp135,798,617,064.00 (one hundred thirty five billion seven hundred ninety eight million six hundred seventeen thousand six hundred forty rupiah) with details as stated in the Attachment which is an integral part of this Regional Regulation.

Part Two
Source

Article 4

Regional Government Capital Participation as referred to in Article 2 comes from the 2021 Fiscal Year APBD Amendment.

CHAPTER III
BUDGETING

Article 5

The budgeting of Regional Government Capital Participation as referred to in Article 4 is grouped into the regional financing expenditure budget of the Regional Government Capital Participation type.

CHAPTER IV
FORM OF CAPITAL PARTICIPATION

Article 6

(1) Form Government Capital Participation The area as referred to in Article 4 is in the form of money.

(2) The management of Regional Government Capital Participation as referred to in paragraph (1) is carried out in accordance with the provisions of laws and regulations concerning Regionally-Owned Enterprises.

CHAPTER V
USE, ADMINISTRATION AND
ACCOUNTABILITY

Article 7

Regional Government Capital Participation as referred to in Article 6 is used for the development of wastewater programs.

Article 8

Administration And accountability Management of Regional Government Capital Participation as referred to in Article 7 is carried out in accordance with Government Accounting Standards.

Article 9

The Surakarta City Regional Drinking Water Company is annually responsible for conveying accountability report in the form of a summary of performance realization and company financial reports to the Mayor through the Supervisory Board.

CHAPTER VI CLOSING

Article 10

This Regional Regulation comes into force on the date of promulgation.

So that every person knowing it, order the promulgation of this Regional Regulation by placing it in the Regional Gazette of Surakarta City.

1. GENERAL

Based on Surakarta City Regional Regulation Number 13 of 2017 concerning the Surakarta City Regional Drinking Water Public Company, the nature of the business of the Regional Drinking Water Public Company is to prioritize the implementation of public benefits (Public Service) in addition to seeking profit as a source of regional original income while adhering to the requirements of efficiency and effectiveness, the principles of corporate economics, the implementation of good corporate governance, and providing good services to the community. In order for the Regional Drinking Water Public Company to be able to provide wastewater services to the community, while at the same time being able to provide economic benefits for regional original income, the Surakarta City Regional Drinking Water Public Company requires capital participation from the Surakarta City Government.

In order to manage community wastewater, the Surakarta City Government needs to stipulate a Regional Regulation on Capital Participation of the Surakarta City Government which stipulates capital participation in the form of money amounting to IDR 9,000,000,000.00 (nine billion rupiah) in the Surakarta City Regional Drinking Water Public Company which is used in developing wastewater program services.

The purpose of Regional Government Capital Participation is to obtain economic, social and/or other benefits. The purpose of Regional Government Capital Participation includes:

- a. improving services to the community in the field of wastewater;

- b. benefits in the form of profit sharing and growth in the value of Regional Drinking Water Public Companies that receive investment from the Regional Government;
- c. improvements in the form of services and profits for investment results; and/or
- d. increasing the receipt of Regional Original Income.
